In exercise of the powers conferred by 56 of the Partnership Act (2024 Revision), the Cabinet makes the following Regulations —

Citation and commencement

- 1. (1) These Regulations may be cited as the Partnership (Fees) Regulations, 2024.
 - (2) These Regulations come into force immediately after the *Partnership* (Amendment and Validation) Act, 2024 comes into force.

Fees

2. The prescribed fee for the item specified in column 2 of the table in the Schedule is the corresponding amount specified in column 4 of the table in the Schedule.

Repeal

3. The *Partnership (Fees) Regulations (2007 Revision)* are repealed.
