FOREWORD

The Cayman Islands is committed to maintaining the stability of its financial services industry and other industries which form an integral part of its economy. In response to the dynamic landscape of regulatory requirements and international standards, significant technological updates with respect to the reporting of beneficial ownership information has been undertaken by the Cayman Islands.

This technical guidance document (**Guidance**) serves as a comprehensive guide to the enhancements of the comma separated values file format (**CSV File**) which is used by industry members to report beneficial ownership information via the corporate administration platform (**CAP**).

APPLICABILITY

This Guidance applies to any trust and/or corporate services provider (**TCSP**) undertaking beneficial ownership filings via CAP with the Cayman Islands Competent Authority for Beneficial Ownership (**Competent Authority**).

2. IMPLEMENTATION GUIDELINES

2.1 Transitional Arrangements

The new CSV File includes all data fields required by the [Beneficial Ownership Transparency Act, 2023 \(Act\)](#) and once published, the Beneficial Ownership Transparency Regulations, 2024, (Regulations). TCSPs will be enrolled into the new updated system in groups as notified by the Ministry of Financial Services & Commerce (**Ministry**). To facilitate efficient industry transition, TCSPs will be advised of the date to cease beneficial ownership filings using the old CSV File. Once a TCSP has been enrolled and commences use of the new CSV File, all fields within the new CSV File may be populated.

Please note that new data points introduced by the Act and Regulations will be optional until such time as advised by the Ministry (**Compliance Date**). TCSPs are encouraged to use this transitional period to gather and verify the new data points introduced by the Act and Regulations.

During this transitional period, TCSPs are encouraged to raise any issues with the [Technical Support Team](#) to ensure effective remediation. Once the new CSV File is implemented, a TCSP will no longer be able to use the old CSV File to file beneficial ownership information with the Competent Authority.

2.2 Data Validation, Quality Assurance & Error Messaging

Enhancements have been made to the data validation process to ensure beneficial ownership data submitted via CAP conforms to the rules of the new CSV File. TCSPs are advised to perform thorough reviews prior to submission to avoid potential errors in the validation process.

An Error Messaging Guide will be issued to support the filing process.

3. CSV FILE DATA FIELDS

3.1 Order of Fields & Naming Conventions

No changes should be made to the CSV File. It is imperative that the order of the fields and their respective names remain unchanged. Any changes to the order of the fields or the names of fields will result in upload errors.

3.2 Data Fields, Description & Status

The Act introduces a number of new data fields to the beneficial ownership register. In order to facilitate the filing of adequate, accurate and current information, the table below has been provided as reference for the type of information required for each data field.

The below is a guide when completing the BO Status field.

BO STATUS	use when...
<i>legalPerson</i>	• a Legal Person is categorised in section 12(1) (a) through (d) or 12(9) of the Act • upon entering this status, the only data required will be in accordance with section 12 of the Act • refer to Appendix A
<i>confirmed</i>	• when the RBO's particulars are confirmed
<i>pending</i>	• the RBO's particulars are not confirmed • upon entering this status, all fields <u>except</u> Entity, Year and Month are optional
<i>noChange</i>	• there is no change to the information previously filed (during the last filing) with respect to the relevant RBO • upon entering this status, only the following fields will be mandatory: (i) Entity (ii) Year (iii) Month (iv) BO Status
<i>deleted</i>	• an RBO should be removed in the system because of an error

NB. "Removed" is not a status available in the CSV File. This status appears on the Registrar's system to indicate that an RBO was removed from the beneficial ownership register as a result of the CSP selecting the status "deleted" in the CSV file.

3.3 Matrix by BO Status & RBO Type

For the avoidance of doubt, a matrix has been provided at Appendix B - Matrix by BO Status & RBO Type which indicates the data fields which are (i) mandatory, (ii) conditional or (iii) optional based on BO Status and RBO Type.

Appendix B has been developed and included for the benefit of information technology personnel/teams when implementing the new CSV File pre and post Compliance Date.

For further clarity, please refer to the Act and Regulations which should always be relied on to determine the obligations and relevant data to be provided.

3.4 Post Compliance Date

Upon enrolment of all TCSPs and successful transition to the new CSV File, this Guidance will be updated to reflect all mandatory and optional fields.

For the avoidance of doubt, the fields below (excluding renamed data points or options within new fields) were introduced by the Act. Post Compliance Date, the fields below will be mandatory based on BO Status and RBO Type.

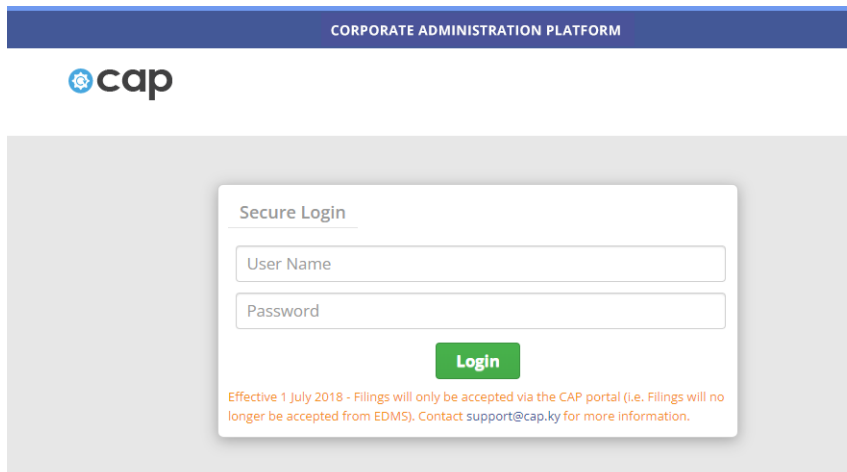

4. POPULATING AND SAVING THE BENEFICIAL OWNERSHIP REGISTER

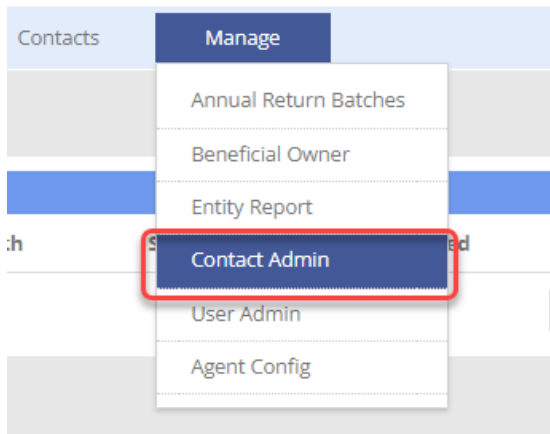
Populate beneficial ownership information in the new CSV File and save the information by following the steps below.

- i. Log into the CAP portal by launching the browser and going to <https://cap.secure.ky>. The recommended browsers for this task are **Google Chrome** and **Mozilla Firefox**.

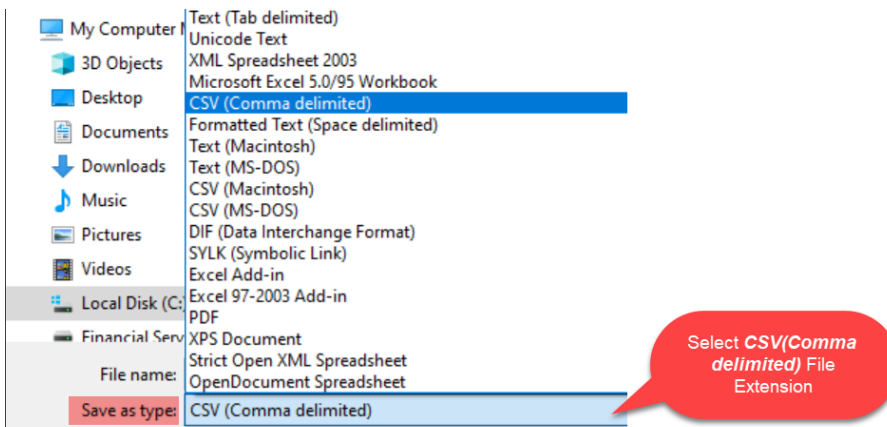

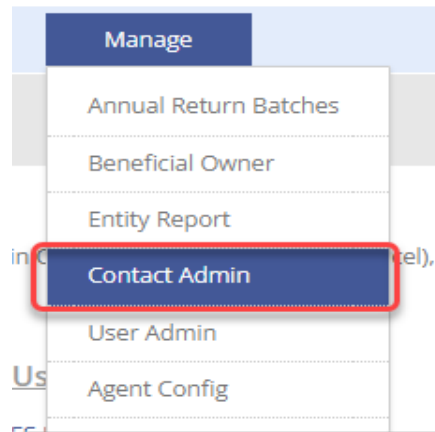
- iv. Populate the **Sample Beneficial Ownership Upload** file with the beneficial ownership information to be filed with the Competent Authority. Please ensure that no punctuation marks are used.
- v. Once complete, it is important that the document is saved in the CSV File type. The manner in which this may be accomplished will vary based on editor used. For example, when using Excel and saving the document, the ability to choose a “Save as type” (below the “File name” field) will be provided. “CSV (Comma delimited)” will appear as one of the options available - this file type should be chosen.



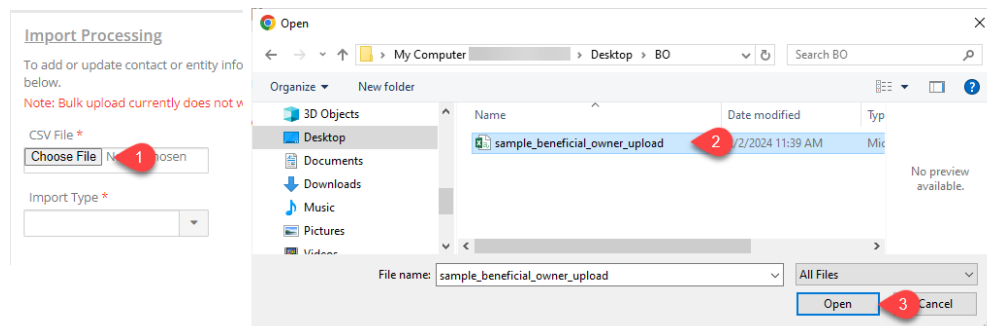
5. UPLOADING THE BENEFICIAL OWNERSHIP REGISTER

Upload completed CSV File by following the steps below.

- i. On the Contact Administration screen, click the **Manage** tab and then click **Contact Admin**.



- ii. Once the page loads, click on **Choose File** (under the CSV File*) and select the beneficial ownership file which should be filed with the Competent Authority (refer to 1, 2 & 3 in the screenshot below).

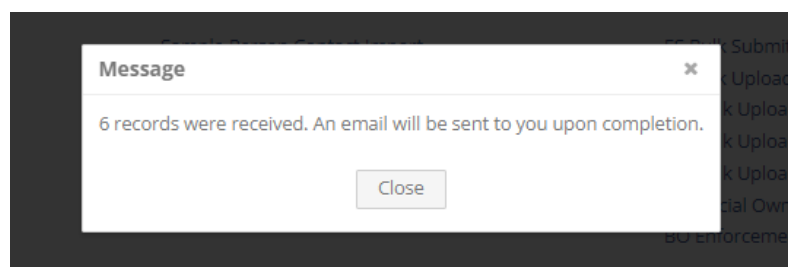


Once Open has been clicked (above), the file name will be displayed next to the **Choose File** button (under the CSV File*).
