



**NOTICE TO DISSENTING SHAREHOLDERS**

*(pursuant to section 88(1) of the Companies Law (1998 Revision))*

In the matter of..... Limited (*hereinafter called "the transferor company"*)

WHEREAS on the .....day of....., 19..., the transferee company made an offer to all the holders of (*if the offer is limited to a certain class or classes of shares, state description of that class or those classes*) shares in the transferor company (*state shortly the nature of the offer*) AND WHEREAS up to the..... day of..... 19..., being a date within four months after the making thereof, such offer was approved by the holders of not less than ninety per cent in value of the said.....shares.
